All stock issued by this corporation shall be common voting stock of a single class. The number of shares of stock that this corporation is authorized to have outstanding at any one time is: 500.

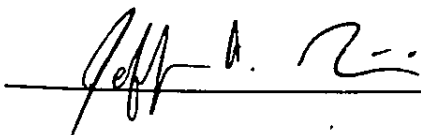
ARTICLE 4: INITIAL REGISTERED AGENT AND REGISTERED OFFICE

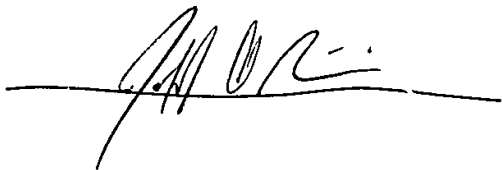
