ARTICLES OF INCORPORATION
OF
JUDITH A. RODNITE, M.D., P.A.
(A Professional Corporation)

The undersigned, who is duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

JUDITH A. RODNITE, M.D., P.A.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purposes for which the Corporation is organized is to practice medicine.

Article 4. Principal Office and Mailing Address. The principal place of business of the Corporation is at 1068 Goodlette Road, N., Naples, Florida 33940. The mailing address of the Corporation is 2888 Tennis Club Drive, Suite 600, West Palm Beach, Florida 33417.

Article 5. Initial Registered Office and Agent. The initial registered office of the Corporation is at Bond, Schoeneck & King, P.A., 1167 Third Street South, Suite 107, Naples, Florida 33940. The name of the initial registered agent at that address is Dennis P. Cronin, Esq.

Article 9. Commencement of Existence. The Corporation's existence shall commence upon the filing of these Articles of Incorporation with the Florida Secretary of State.


