The Undersigned Incorporator, for the purpose of forming a Corporation under the Florida (1) STATE  
Business Corporation Act, hereby adopts the following Articles of Incorporation. TALLAHASSEE, FLORIDA

**ARTICLE I**

The name of the Corporation shall be Perkins & Sons Electrical Contractors, Inc., and it shall hereinafter be referred to as "Corporation".

**ARTICLE VII**

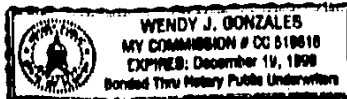
