**ARTICLE I- NAME**

The name of this Corporation is FLOWERS FOR ALL OCCASIONS, INC.

**ARTICLE II- DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III- PURPOSE**

The purpose of this Corporation is to engage in Designing and Arranging Flowers for resale and any other activity or business permitted under the Laws of the United States and Florida.

**ARTICLE IV- CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE V - INITIAL REGISTERED  
OFFICE AND AGENT**

The initial registered office of this Corporation shall be, 1271 N. Ocean Drive, Riviera Beach, FL 33404, and the initial agent of this Corporation at such office shall be Betty Fulwood, upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping and office open for service of process.

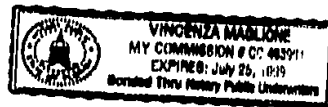
