OF

The **ARTICLES OF INCORPORATION** of **C & K ELECTRICAL SERVICES, INC.**, are as follows:

**ARTICLE I.**

The name of this corporation shall be **C & K ELECTRICAL SERVICES, INC.**

**ARTICLE II.**

The duration of this corporation is perpetual.

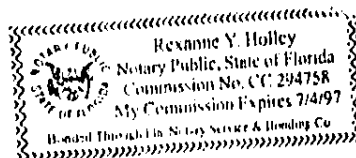

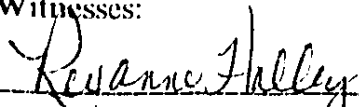
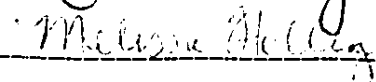
