ARTICLE I - NAME

The name of the corporation, **COMMERCIAL LEGAL VIDEO SERVICES, INC.**, located 630 Southwest 69 Terrace, Pembroke Pines, Florida 33023.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE X - INCORPORATOR

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation in accordance with the provisions of the Florida General Corporation Act.


