#### ARTICLES OF INCORPORATION

The undersigned natural person, competent and licensed as a realter in the State of Florida, acting hereby as incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 621, Florida Professional Services Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

I

#### NAME OF CORPORATION

The name of this corporation shall be Loretta Moody, P.A.

ΙI

#### **PURPOSES**

The general nature and purposes of business to be transacted, promoted and carried on by the Corporation are as follows:

- a. To engage in every aspect of a realtor and all matters concerning the sale, rental and management of real or personal property and business opportunities.
