ARTICLES OF INCORPORATION
OF
SPECIAL PROPERTIES, INC.

ARTICLE I

The name of this corporation is Special Properties, Inc.

ARTICLE II

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV

This corporation shall have perpetual existence commencing upon filing of these articles. The effective date of this corporation shall be June 14, 1996.
