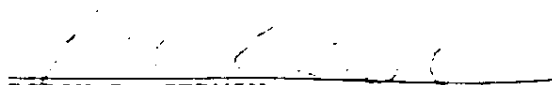

ARTICLES OF INCORPORATION

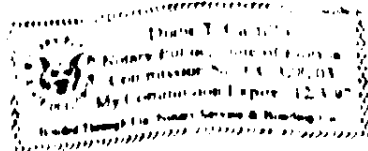
- FIRST: The name of this corporation is: Global Lounge, Inc.
