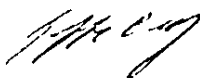

ARTICLE I

The name of this corporation is Chacara Investments, Inc., whose principal address is 6970 Lee Street, Hollywood, Florida 33024.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in investments, a business permitted under the laws of the State of Florida.

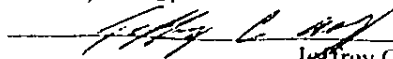
