The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is **CANE AIR CONDITIONING, INC.**

ARTICLE II. DURATION

EFFECTIVE DATE

The term of existence of the corporation is perpetual. Corporate existence shall begin on June 17, 1996.

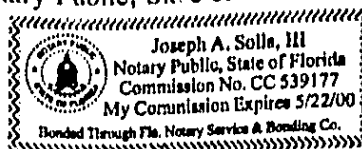
