ARTICLE I - NAME :

TALL ANASSEE FLORIDA The name of this corporation is: CLEAN SWEEP HOUSEKEEPING SEL ICE, INC., hereinafter referred to as the ("Corporation"). ARTICLE 11 - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:
