**ARTICLES OF INCORPORATION
OF
SJRI, INC.**

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

1. NAME

The name of the Corporation is:

SJRI, Inc.

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be June 18, 1996, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

The purpose for which the Corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws, including the ownership and operation of real property.

4. CAPITAL STOCK

The Corporation shall have the authority to issue 100 shares of common stock, in one class only, each with a par value of \$1.00.

**5. REGISTER AGENT AND OFFICE

The registered agent of the Corporation shall be Kristopher E. Fernandez, Esquire.

The Initial Board of Directors shall have two members whose names and addresses are as follows:



7. INCORPORATOR


