

## ARTICING OF INCORPORATION OF PREDATORY VENTURES, INC.



#### ARTICLE I -- NAME

The name of this corporation is PREDATORY VENTURES, INC.

#### ARTICLE II -- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III -- PURPOSE

This corporation is organized for the purpose of:

- (a) Operating a nightclub primarily for teenage patrons; and any other business auxillary thoreto including, but not limited to, concessions, merchandising, and related promotions; and
