The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME

Section 1.1 Name. The name of the corporation is Mickay's Bar-B-Q, Inc.

ARTICLE II - DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually.
