ARTICLES OF INCORPORATION
OF

COURTESY ENTERPRISES, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is COURTESY ENTERPRISES, INC. The street address of the principal office of the Corporation is 600 N. Hwy. 17-92, Longwood, Florida 32750

ARTICLE II

The existence of the corporation shall begin on June 20, 1996, and have perpetual existence.

ARTICLE III

The corporation is organized for the purpose of operating a business and any and all other lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares.
