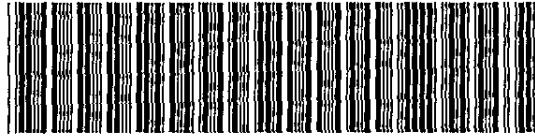

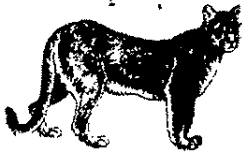


## 1. ACTION TO DISSOLVE

### 1.1. Action to Dissolve this Corporation Pursuant to Section 607.1402(6), Florida Statutes


- 1.1.1. Miriam Jaskierowicz-Arman, the sole shareholder of this corporation, shall take action to dissolve Music Vision International, Inc. (Document P96000053305), a Florida profit corporation, pursuant to section 607.1402(6), Florida Statutes. Action taken under this section must be by written consent describing the action, dated and signed by the approving shareholders having the requisite number of votes of each voting group entitled to vote thereon. This written consent must be delivered to the principal office of the corporation within 60 days of the date the sole shareholder signed this written consent for this written consent to be effective, pursuant to section 607.0704(1), Florida Statutes. A consent signed under this section has the effect of a meeting vote, pursuant to section 607.0704(4), Florida Statutes.

### 1.2. Dissolution by Written Consent of the Shareholders

- 1.2.1. Miriam Jaskierowicz-Arman, the sole shareholder of this corporation, consents to dissolve Music Vision International, Inc. (Document P96000053305), a Florida domestic profit corporation, effective 8 September 2005, pursuant to section 607.1402(6), Florida Statutes. ### **2.2. Name of the Corporation**

- 2.2.1. The name of this corporation is **MUSIC VISION INTERNATIONAL, INC. (Document P96000053305).**

### **2.3. The Date Dissolution was Authorized**

- 2.3.1. The dissolution of this corporation was authorized **31 August 2005.**

### **2.4. Dissolution was Approved by the Shareholders**

- 2.4.1. **Miriam Jaskierowicz-Arman, the sole shareholder of all shares of all classes of outstanding stock, approved the dissolution of this corporation. Thus, the number of votes cast for dissolution was sufficient for approval.**

### **2.5. The Effective Date of the Articles of Dissolution**

- 2.5.1. The effective date of the articles of dissolution shall be **31 August 2005.**
