ARTICLES OF INCORPORATION

ARTICLE T - NAME:

The name of this corporation is KOKOMO REALTY, INC. (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing on the date set forth below (i.e., the date of subscription and acknowledgement of these Articles of Incorporation).

ARTICLE III - PURPOSE:
