**ARTICLE I
CORPORATE NAME**

The name of this Corporation is CUTTING EDGE HORTICULTURAL SERVICES, INC.

ARTICLE II

DURATION

This Corporation shall have perpetual existence, and shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.
