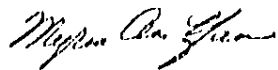

ARTICLE I

The name of the corporation is TWIN OAKS DEVELOPMENT, INC. (hereinafter called the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1399 West State Road 434, Longwood, Florida 32750.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

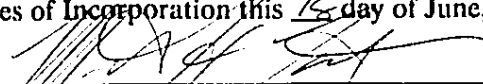

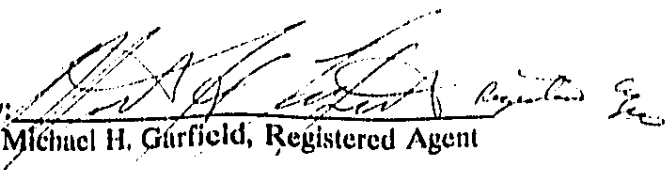

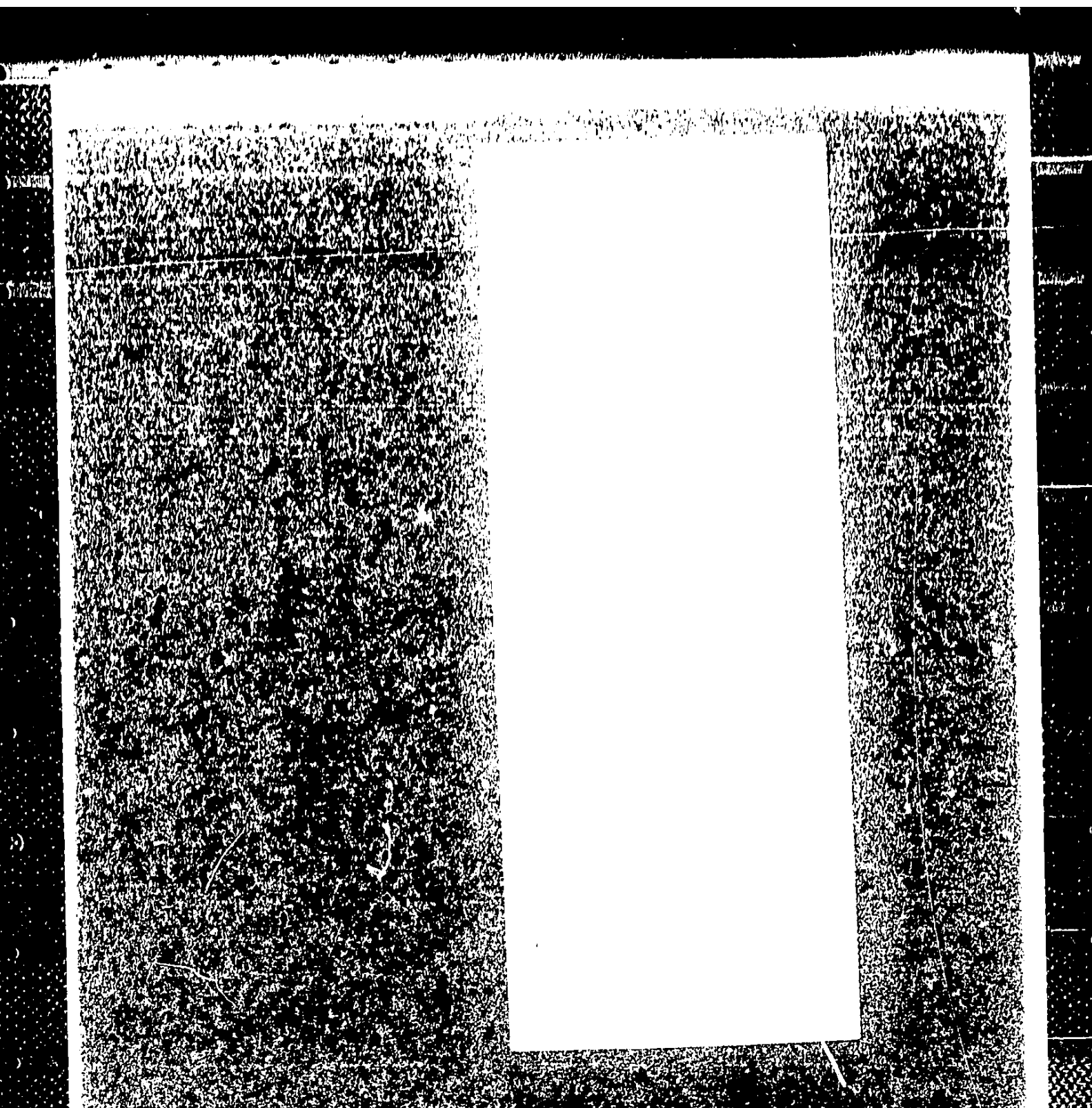
