2. Article I of the Articles of Incorporation of Centrefund Development Corp. is

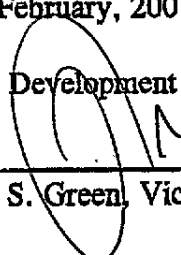
hereby amended to read:

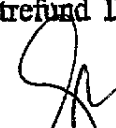
