CERTIFICATE OF INCORPORATION

OF

THUMBING BY SALCMON AND ASSOCIATES INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter mentioned, and we hereby make, subscribe and acknowledge and bile with the Secretary of State of Florida this Certificate of Incorporation and to that on we do, by this Certificate, set forth:

ARTICLE 1
