We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I.  
IDENTIFICATION

The name of the corporation is Tropic Zone Performance, Inc.

ARTICLE II.  
PERIOD OF EXISTENCE

This corporation shall exist in perpetuity from the date of filing.

ARTICLE III.  
PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Business Corporation Law. The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body.

ARTICLE IV.  
SHARES

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock.
