ARTICLES OF INCORPORATION

OF

CYPRESS TRACE AMOCO INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, as particularly set forth in Chapter 607, Florida Statules, as last amended, hereby adopts the following Articles of Incorporation:

ARTICLE L. NAME

The name of the Corporation is: CYPRESS TRACE AMOCO INC.

ARTICLE II. DURATION

The duration of the Corporation is perpetual.

ARTICLE III. PURPOSE

The general purposes for which the Corporation is organized are the following:
