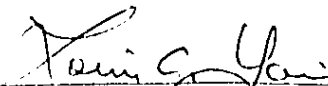

7. Any business that is allowed by the laws of the state of Florida.

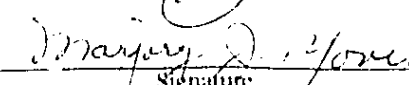
ARTICLE VIII SHARES IN THE CORPORATION
