# ARTICLES OF INCORPORATION OF PLANITUDE, INC.

In compliance with the requirements of Chapter 607 Floriday Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a busi-

#### ARTICLE I

The name of the corporation is Planitude, Inc.

### ARTICLE II

The existence of the corporation shall be perpetual, until dissolved in accordance with law, and shall commence on the filing of these Articles with the Florida Department of State.

### ARTICLE III

The street address of the initial principal office of the corporation is 1932 Nowell Branch Road, Winter Park, Florida 32792.

The maximum number of shares of stock which the corporation is authorized to issue is 7,500 shares of common stock, with par value of 10¢ per share.
