Articles of Incorporation
of

THE STATE OF FLORIDA, ss. I, [unclear], Secretary of State, do hereby certify that the foregoing is a true and correct copy of the original filed in my office on the 20th day of June, 1996.

ARTICLE I

The name of the corporation shall be

ARTICLE II

This corporation shall have the right to sue and be sued, to contract, to hold real and personal property, to acquire, hold, convey, lease, mortgage, and otherwise dispose of real and personal property, to execute and deliver any instrument which may be necessary or proper for the carrying out of its business, and to do all things which natural persons are permitted to do by the laws of the State of Florida, and to do all things which the State of Florida permits to be done by corporations organized under Chapter 667, Florida Statutes, and the laws of any other state or territory of the United States, subject to the limitations, if any, imposed by law.

ARTICLE III

This corporation shall have the right to issue shares of stock on the date of subscription and acknowledgment of the shares, and thereafter to issue shares of stock to any person who may be entitled to receive the same.

ARTICLE IV
