

WE, THE UNDERSIGNED, being desirous of associating ourselves together for the purposes of becoming a corporation under the laws of the State of Florida, do make, subscribe and acknowledge the Articles of Incorporation, pursuant to Section 55 of the Florida General Corporation Act, and other applicable provisions of the Corporation Law of the State of Florida, and acts amendatory thereof and supplemental thereto.

Article I

NAME

The name of this Corporation is A.R.TECHNOLOGIES, INC.
(hereinafter the "Corporation").

Article II

NATURE OF BUSINESS

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the corporation laws of the State of Florida.




