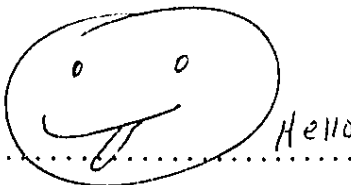

**ARTICLE I - Name and Principal Office**

**ARTICLE II - Duration**

This corporation shall have perpetual existence.

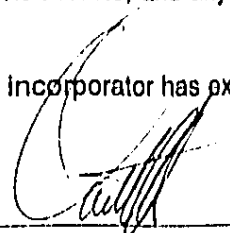
ARTICLE VIII - Indemnification

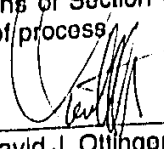
