**ARTICLES OF INCORPORATION

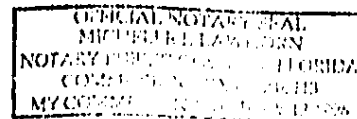

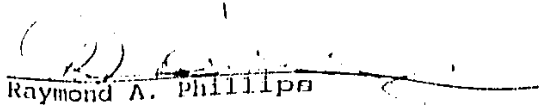
