**FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE**

THIS MATTER having come on for hearing, and the parties having agreed to the entry of the Final Judgment of Dissolution of Marriage, and this Honorable Court being otherwise fully advised of the premises, it is hereby:

**ORDERED AND ADJUDGED THAT:**

1. The Court has jurisdiction of the parties and the subject matter of this action.
2. The bonds of marriage between the Petitioner, **RUDOLPH JOHN CERVANTES**, and the Respondent, **PEGGY L. CERVANTES** are dissolved for the reason that the marriage is irretrievably broken.
3. The Marital Settlement Agreement between the parties, introduced into evidence and marked as Petitioner's Exhibit A was executed voluntarily after full disclosure, and is in the best interests of the parties, and is approved and incorporated in this Judgment by

reference and the parties are ordered to comply with it. The

Agreement shall not merge with the Final Judgment, but shall survive it.

4. The Wife's pre-marriage name of **PEGGY LYNNE MITCHELL** be restored. The Wife has never been adjudicated bankrupt either individually or jointly with the Husband or any other person. The Wife's request to have her pre-marriage restored is not made for any ulterior or illegal purpose and will not adversely affect any creditors or other persons.

5. This Court shall retain jurisdiction of this cause and the parties for the purposes of enforcement and for the entry of such further Orders as may be proper.
