ARTICLES OF INCORPORATION OF

ARTICLE 1 - NAME

The name of the corporation is: RICHTMAN CORP.

ARTICLE IL-PURPOSES

This corporation is organized for the following purposes:

- A. To manufacture, buy, sell, export, import, and deal at retail and wholesale in dresses, skirts, blouses, separates, weskits, shorts, pedal pushers, slacks, bathing suits, beach coats, jackets, coats, suits, and other sportswear and women's and children's apparel of every nature and description, and in dress accessories and novelties of every nature and description, and in dress accessories and novelties of every nature and description, and in any other articles which may be conveniently or advantageously handled in conjunction with the foregoing business.
- B. To export from and import into the United States of America and its territories and possessions, and any and all foreign countries, as principal or agent, merchandise of every kind and nature, and to purchase, sell, and deal in and with, at wholesale and retail, merchandise of every kind and nature for exportation from, and importation into, the United States, and to and from all countries foreign thereto, and for exportation from, and importation into, any foreign country, to and from any other country foreign thereto and to purchase and sell domestic and foreign merchandise in domestic markets, and to do a general foreign and domestic exporting and importing business.
- C. To manufacture, buy, sell, dye, stain, buff, polish, emboss, stamp, burn, treat, handle, and work in leather, skins, fabrics, papers, rubbers, and composition substances of all kinds. To design, manufacture, buy, and sell, at wholesale or retail, suitcases, trunks, sample cases, traveling bags, handbags, pocketbooks, wallets, billfolds, jewel cases, table covers, book covers, robes, wall coverings, pillow covers, saddlery, harnesses, gloves, clothing, headgear, footwear, puttees, leggings, belts and belting, valves, vehicle coves, hoods, and tops, and curtains, straps, sole leather, string leather, rawhide, materials and supplies for shoemakers, harnessmakers, upholsterers,

and feather workers of all kinds. To make, buy, and sell any all things made wholly or in part from leather, imitation leather, substitutes for feather, oilcloth, paper, papier-mache, carry as, and mohair.

- D. To manufacture, buy, sell and deal in at wholesale and retail, dry goods, clothing, wearing apparel and textile fabrics of every kind, hats, caps, millinery, boots, shoes, furnishing goods, fancy goods, and all articles and merchandise of like general character and description, and to conduct the business of general dry goods and clothing merchants, tailors, drapers, haberdashers, milliners, dressmakers and general outfitters.
- E. To such extent as a corporation organized under the Business Corporation Law of this state may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other corporations, firms or individuals, all and everything necessary, suitable, convenient or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this Corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the Business Corporation Law of this state or under any act amendatory thereof, supplemental thereto, substituted therefor.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue Fifty (50) shares of common stock without nominal or par value.

ARTICLE IV - INITIAL REGISTERED AND PRINCIPAL OFFICE AND AGENT
