ARTICLES OF INCORPORATION OF CLOSING SKRVICKS, INC.

I, the undersigned, being of legal age and a natural person ORIVA do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be: CLOSING SERVICES, INC., 18 N.W. 18th Street, Delray Beach, Florida 33444.

ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.
