

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be PMLD3, Inc.

**ARTICLE II
PURPOSE**


ARTICLE VI **INCORPORATORS**




