ARTICLES OF INCORPORATION

OF

MANOR ENTERPRISES, INC.

ARTICLE I

The name of this corporation is MANOR ENTERPRISES, INC. Its business shall be carried on at Broward County, Florida, and such other points or places in the State of Florida and in the United States and countries as may, from time to time, be authorized by the Board of Directors. Its principal office shall be at: 10803 Denver Drive, Cooper City, Florida, 33026.

ARTICLE II

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To own, lease, rent, operate and manage restaurants, hotels, apartment houses, taverns, bars, drug stores, barber shops, garages for motor vehicles, manufacturing plants, distribution and assembly plants, laundry and dry cleaning services, newstands, dance halls, theaters and other places of public entertainment.

To purchase, acquire, hold, improve, sell, convey, assign, lease, mortgage, encumber, hire, invest and deal in real and personal property of every name and nature.

To buy, sell, trade, manufacture, assemble, and deal in and with goods, ware and merchandise of every kind and nature; to carry on such business as wholesaler, retailer, importer an exporter, to acquire all such merchandise, supplies materials and

other articles as shall be necessary or incidental to such business.

SECTION I. That of engaging in any activity or business permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity or business permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations for profit by Chapter 607, Florida Statutes, as amended.

SECTION II. To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers, or any part thereof; provided, that the same be not inconsistent with the laws under which this corporation is organized.

ARTICLE III

The Corporation is authorized to issue 300 shares at no par value stock, at \$1.00 per share, which shares shall be designated "Common Stock."

ARTICLE IV

Unless otherwise provided for in the Articles of Incorporation, each holder of capital stock in this corporation shall be entitled at each shareholder's meeting to one vote for every share of stock standing in his name on the books of the corporation; but transferees of shares that are transferred on the books of the corporation within ten (10) days next preceding the date set for a meeting shall not be entitled to notice of or vote at the meeting.

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class or series, as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

This corporation shall begin business with a capital of not less that FIVE Hundred (\$500.00) Dollars and the undersigned incorporators do hereby state that there has already been paid into the corporation on behalf of the subscribers set forth herein the sum of Five Hundred (\$500.00) Dollars.

ARTICLE VII

This corporation shall exist perpetually.

ARTICLE VIII


