THE UNDERSIGNED FOR THE PURPOSE OF FORMING A CORPORATION, SEE, FLORIDA
UNDER THE FLORIDA GENERAL CORPORATIONS ACT, HEREBY ADOPTS THE
FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I - NAME

THE NAME OF THE CORPORATION IS: A-TEK CHEMICAL SYSTEMS, INC.

ARTICLE II - PURPOSE

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF
TRANSACTIONING ANY AND ALL BUSINESS PERMITTED UNDER THE LAWS OF

ARTICLE III - CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE FOUR

ARTICLE VI - BY-LAWS

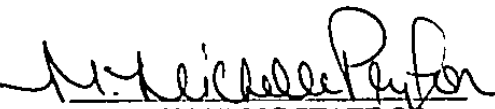
