#### ARTICLE IX. AMENDMENT

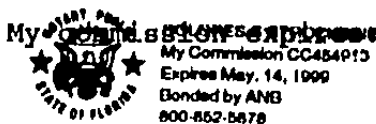


