ARTICLE I

Name: The name of this corporation is:

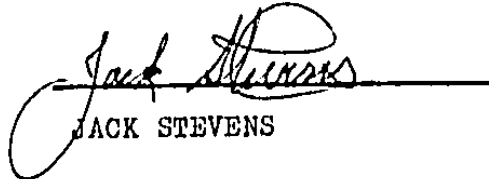
