ARTICLES OF INCORPORATION

OF

Weller Construction Enterprises, Inc.

The undersigned incorporators make, subscribe, acknowledge, and file with the Department of State of the State of Floridations and English of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Corporation is Weller Construction Enterprises, Inc., with a principal office of 493 Sundown Trail, Casselberry, FL 32707 and a mailing address of P.O. Box 521881, Longwood, FL 32752-1881.

ARTICLE II: TERMS OF EXISTENCE

This Corporation shall commence as of July 1, 1996 and shall have perpetual existence.

ARTICLE III: NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV: CAPITAL STRUCTURE

The total number of shares of capital stock authorized to be issued by the Corporation will be one thousand (1,000) shares of common stock of the same class, having a par value of no par per share.
