The undersigned incorporators to these articles of incorporation, natural persons competent to contract, hereby forms a Domestic Corporation under the laws of the State of Florida pursuant to the provisions of Section 607.164 Florida Statutes.

**Article I: Name**

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

## **Article V: Capital Stock**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock having a nominal or par value of One Dollar (\$1.00), in currency of the United States of America, per share.

## **Article VI: Pre-Emptive Rights**

Every shareholder, upon the sale of any new stock of this corporation, shall have the right to purchase his/her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. Every shareholder will also have the right of first refusal upon the offer for sale of existing shares of stock.

## **Article VII: Duration**

This corporation shall have perpetual existence commencing on the date of filing and acknowledge of these Articles of Incorporation, unless sooner dissolved according to law.

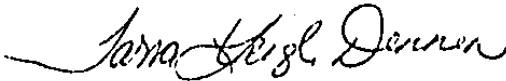

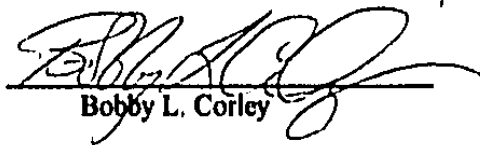
