The undersigned, acting as incorporator to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE_I

NAME

The name of the corporation is:

SALZCO, INC.

ARTICLE II

The principal office of the corporation is located at:

ARTICLE III

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- (A) To manufacture, import/export, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

- (D) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
