The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I.

NAME

The name of the Corporation is FATHER DIESMONDOVIC MARKOWSKI, INC. The address for the principal office is: 2109 Jerusalem Street, Jacksonville, Florida 32209.

ARTICLE II.

DURATION

The Corporation shall have perpetual existence, and the corporate existence shall commence upon signing these Articles of Incorporation, or later if required by law.

ARTICLE III.

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV.

SECTION 1244 STOCK

The Corporation is authorized to issue 100 shares of one dollar (\$1.00) par value Common Stock. It is the intent of this charter that the Directors may sell the capital stock of the corporation in accordance with the conditions of Sections 1242-1244, inclusive of the Internal Revenue Code of 1954, as amended.

INITIAL PRINCIPAL OFFICE

ARTICLE VI.

INITIAL REGISTERED AGENT

LEUKEL, ESQUIRE, designated as its' agent to accept service of process within the State of Florida. ARTICLE VII

INITIAL BOARD OF DIRECTORS

The Corporation shall initially have two (2) directors to hold office until the first annual meeting of shareholders and successors shall have been duly elected and qualified, or until earlier resignation, removal from office, or death. The number of

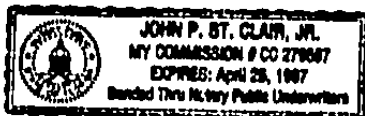
