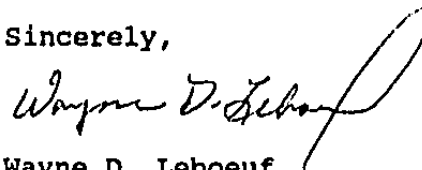

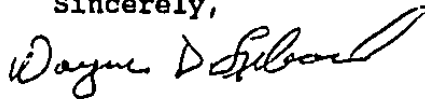

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be Creative Futures International, Inc., and its principal office address is: 2500 SE 7 Place, Homestead, Florida 33033.

ARTICLE II. DURATION. This corporation is to exist perpetually.

ARTICLE III. PURPOSE. This corporation is organized for the purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK. This corporation is authorized to issue five thousand (5,000) shares of common stock at \$1.00 per share.

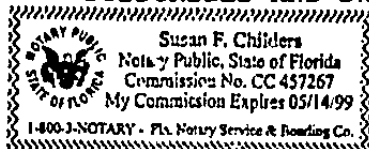

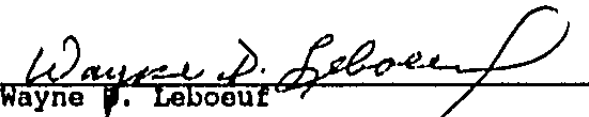
