## ARTICLES OF INCORPORATION OF TRADEFLEX, INC.

ARTICLE I:

SECRETARY OF STATE FALLAHASSEF FLORIDA
The name of this corporation is TRADEFLEX, INC.

This ARTICLE II: corporation shall have perpetual oxistence.

This corporation is organized for the purpose ARTICLE III: of engaging in any activity or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV: The maximum number and class of shares of capital stock which this corporation is authorized to have outstanding is one hundred shares of common capital stock with a par value of One Dollar (\$1.00) per share.
