The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be W.W.I. OF PALM BEACH, INC.

ARTICLE II

ARTICLE III


ARTICLE IX



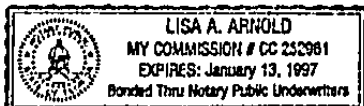


