ARTICLE I

The name of this corporation is: **CASPIAN SEAFOOD, INC.** The principal office of the corporation is located at **660 South McDuff Avenue, Jacksonville, Florida 32205.**

ARTICLE II

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

ARTICLE III

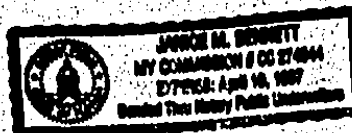
