# ARTICLES OF INCORPORATION

## **ARTICLE I**

The name of this corporation is: CASPIAN SEAFOOD, INC. The principal office of the corporation is located at 660 South McDuff Avenue, Jacksonville, Florida 32205.

## ARTICLE II

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

## **ARTICLE III**

The total number of authorized shares of the capital stock of this corporation is Seven Thousand, Five Hundred (7,500) shares of common stock, all of which shall have a par value of Ten Cents (\$.10) each. Each issued and outstanding share of common stock shall be entitled to one vote.

#### **ARTICLE IV**

This corporation shall have perpetual existence. The existence of this corporation shall begin as of the date of the filing of these articles.

#### **ARTICLE V**
