# ARTICLES OF INCORPORATION

# A PROFESSIONAL CORPORATION

The undersigned, duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE ONE

#### NAME

The name of the corporation is FRANK M. PALMOUR & ASSO-CIATES, P.A.

# ARTICLE TWO

# REGISTERED OFFICE AND AGENT

The location and address of the Corporation's initial registered office in Florida is 38 North Park Avenue, Apopka, Orange County, Florida 32703. The initial registered agent at the registered office is Frank M. Palmour.

#### ARTICLE THREE

#### **PURPOSE**
