The undersigned incorporator, a natural person competent to contract, hereby files these Articles of Incorporation in order to form a Corporation under and pursuant to the laws of the State of Florida, and for that purpose, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation is Vision Printing, Inc.

ARTICLE II. ADDRESS

ARTICLE III. PURPOSE
