ARTICLES OF INCORPORATION



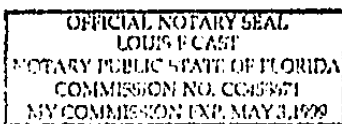
